## Message from the Head of School

I am looking forward to seeing you all at this evening's PotLuck supper. This has become a very popular event in our school calendar and a great opportunity for you, and your children, to meet and greet old and new friends. All of the Ambrosoli staff will be in attendance but remember it's an evening off for the teachers. Your children are your responsibility this evening!

I have been asked a number of times recently about the distinct roles of the Directors and Governors at Ambrosoli so have added some

information below. Please refer to our website for further information.

Ambrosoli International School is owned by Ambrosoli Limited, a Company limited by shares, whose Board of Directors is elected annually at a General Meeting of the Shareholders.

The Board of Directors is responsible for fiscal planning and development matters of the school leaving the academic matters to the Governors and the Head of School.

The role of the Board of Governors is to assist in the overall strategic direction, governance and policy making of the school. The current Chair of the Board is Mr. Robert Kabushenga. The BoG is comprised of both parental and non-parental volunteers, with a maximum of eleven members; one of whom is nominated by the Board of Directors. They are assisted by the Head of School and a teacher representative. Operational and administrative issues are the responsibility of the Head of School and management team.
